School Reopening Plan

2020-2021



Traditional School Setting

- This plan represents a return to the school campus and the classroom where students will interact directly, but safely with their teacher(s) and classmates.
- Teachers will provide in-person instruction, 5 days a week.
- Instruction in core subjects and electives.
- Masks will be required to be worn by all USD 307 students and staff members and social distancing will be observed when and where is necessary.
- Teachers will provide in-person instruction in core and elective classes. Class size will be determined by the building principal.
- Special education classes and support services will continue to be provided.
- K-12 technology provided for all students and staff.
- USD 307 transportation will be provided for eligible students.
- Breakfasts and lunches will be served at both schools.
- KSHSAA sanctioned athletics and activities, will be offered to eligible students according to KSHSAA guidelines and local authorities.
- Cleaning and sanitizing will take place during the course of the school day by both staff and students.

At Home (Remote) Learning

- This option is for the students and parents who do not feel comfortable returning to the school building.
- Internet access is required.
- Students who choose this option will be assessed on the same competencies as their at peers.
- Accommodations in special education and support services will continue to be available.
- Students are required to make daily connections with a teacher. Connections can be either through phone or zoom video conferencing.
- Students are required to maintain a daily log of activities that is equal to a school day, per state requirements. This log is to be signed by a parent or guardian of the student and will be submitted weekly to the school.
- Class instruction time (zoom) will be determined by the classroom teacher and the building principal.
- Families may be able to purchase and/or pick up meals at designated locations (Pending USDA approval) to take home.
- KSHSAA sanctioned athletics and activities, will be offered to eligible students according to KSHSAA guidelines and local authorities.
- Students who choose to Remote Learn may change to On-Site Learning with Building Administration approval.

If traditional school cannot take place, students will continue to learn in one of the following options:

Hybrid Learning

- Students will be divided into two groups:

Red Group: On-Site Learning Monday and Tuesday; Remote Learning Wednesday, Thursday and Friday

White Group: Remote Learning Monday, Tuesday, and Wednesday. On-Site Learning Thursday and Friday

Wednesdays: On-Site Small Group Instruction. Students and parents will be notified if attendance is required on Wednesday.

- On days students are not in the building, distance learning will continue. Each student must:
 - make daily connections with a teacher
 - maintain a daily log of activities that is equal to a school day that is to be signed by parent or guardian to be submitted weekly
- At ESE, students will remain with their classroom teacher, with the exception of specials.
- Masks will be required to be worn by all USD 307 students and staff members and social distancing will be observed when and where is necessary.
- Teachers will provide in-person instruction in core and elective classes. Class size will be determined by the building principal.
- Special education classes and support services will continue to be provided.
- USD 307 transportation will be provided for eligible students.
- Breakfasts and lunches will be served at both schools.
- KSHSAA sanctioned athletics and activities, will be offered to eligible students according to KSHSAA guidelines and local authorities.

All Remote Learning

- Accommodations in special education and support services will continue to be available.
- Students are required to make daily connections with a teacher. Connections can be either through phone or zoom video conferencing.
- Students are required to maintain a daily log of activities that is equal to a school day, per state requirements. This log is to be signed by a parent or guardian of the student and will be submitted weekly to the school.
- Class instruction time (zoom) will be determined by the classroom teacher and the building principal.
- Families may be able to purchase and/or pick up meals at designated locations (Pending USDA approval) to take home.
- KSHSAA sanctioned athletics and activities, will be offered to eligible students according to KSHSAA guidelines and local authorities.
